

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Ratifying the License Agreement Between Pima Community College and the Tohono O'odham Nation and Amendment No. 1 and Approving Amendment No. 2)

RESOLUTION NO. 13-465

1 **WHEREAS, 26 Tohono O'odham Code Chapter 1, Article 4, Section 1402 Contract Approval**
2 **Reserved, subsection (D), reserves to the Legislative Council authority to**
3 **approve "intergovernmental agreements, including but not limited to**
4 **agreements with any other government, subdivision, or entity thereof; law**
5 **enforcement and other memoranda of understanding or agreement; self-**
6 **determination contracts and annual funding agreements; the tribal-state**
7 **gaming compact; and cooperative agreements"; and**

8 **WHEREAS, in 2010 a License Agreement with Pima Community College was entered to**
9 **provide the Education Department office space at the College's Desert Vista**
10 **Campus, but the Agreement and subsequent Amendment No. 1 were not**
11 **approved by the Legislative Council; and**

12 **WHEREAS, the Tohono O'odham Nation Education Department seeks to amend the License**
13 **Agreement and to have the Legislative Council ratify the original Agreement and**
14 **Amendment No. 1; and**

15 **WHEREAS, the Tohono O'odham Nation has consistently supported the pursuit of higher**
16 **education for its members; and**

17 **WHEREAS, Amendment No. 2 to the License Agreement with Pima Community College has**
18 **been reviewed by the Human Resources Development Committee, which**
19 **recommends its approval by the Tohono O'odham Legislative Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council ratifies the**
21 **License Agreement Between Pima Community College and the Tohono O'odham**
22 **Nation and Amendment No. 1 and approves Amendment No. 2.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's Chairman is authorized to**
24 **execute Amendment No. 2 to the License Agreement.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
26 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**
27 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
28 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
31 **the Act of June 18, 1934 (48 Stat.984).**


