

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of no-cost extension and FY 2013 Carry Forward Funds of the US Department of Homeland Security, Federal Emergency Management Agency, FY 2010 Emergency Operations Center Grant, Grant No. 2010-EO-MX-0013 for \$500,000.00)**

**RESOLUTION NO. 13-466**

1 **WHEREAS, the United States Department of Homeland Security (DHS), Federal Emergency**  
2 **Management Agency (FEMA) has distributed grants to states to fund for**  
3 **purchases that provide public safety services within their respective**  
4 **jurisdictions; and**

5 **WHEREAS, the Tohono O'odham Nation submitted an application to FEMA for direct**  
6 **funding under the FY2010 Emergency Operations Center (EOC) Grant Program to**  
7 **enhance emergency management and preparedness capabilities by supporting**  
8 **flexible, sustainable, secure strategically located, and fully inter-operative**  
9 **EOC's with a focus on addressing identified deficiencies and needs; and**

10 **WHEREAS, the United States Department of Homeland Security, Federal Emergency**  
11 **Management Agency has awarded the Tohono O'odham Nation under FY2010**  
12 **Emergency Operations Center (EOC) Grant Program, Grant No. 2010-EO-MX-0013**  
13 **in the amount of \$500,000.00; and**

14 **WHEREAS, Award No. 2010-EO-MX-0013 requires a twenty-five (25%) percent match in the**  
15 **amount of \$166,667.00; and**

16 **WHEREAS, the Tohono O'odham Law Enforcement Account(s) #100-14-5001 in the amount**  
17 **of \$131,670.00 and #001-14-5000 in the amount of \$35,000.00 have obligated**  
18 **funds to meet the twenty-five (25%) percent match of \$166,670.00 ; and**

19 **WHEREAS, the Tohono O'odham Nation has requested and was approved for a six (6) month**  
20 **no-cost extension, revising project end date from November 30, 2013 to May 31,**  
21 **2014; and**

22 **WHEREAS, FY2010 Emergency Operations Center Grant Program No. 2010-EO-MX-0013 has**  
23 **been reviewed by the Budget Office, Office of Grants & Contracts, Executive**  
24 **Office, Domestic Affairs Committee and Budget & Finance Committee of which**  
25 **all recommend acceptance of the grant award by the Legislative Council.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
27 **approves the six (6) month no cost extension, extending the grant period of**  
28 **performance from November 30, 2013 to May 31, 2014 and shall be administered**  
29 **in accordance with the terms of the grant period of performance.**

30 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and**  
31 **authorizes the Office of Emergency Management to expend the carry forward**  
32 **funds from FY 2013 of the FY2010 EOC Grant Program for the FY 2014 from**  
33 **December 1, 2013 through September 30, 2014, in the amount of \$500,000.00.**



2 **forward funds of the 2010 EOC Grant Program No. 2010-EO-MX-0013 on a**  
3 **reimbursement basis from the Tohono O'odham Nation General Fund.**


4 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
5 **Chairperson and any designated official to expend and administer the Budget as**  
6 **attached, provided that any Amendments affecting the funds or funding level is**  
7 **submitted for further prior approval by the Tohono O'odham Legislative**  
8 **Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup>**  
10 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,525.40**  
11 **FOR; -0- AGAINST; -0- NOT VOTING; and 421.1 [11] ABSENT, pursuant to the powers vested in the**  
12 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted**  
13 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
14 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
15 **the Act of June 18, 1934 (48 Stat.984).**


