

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2014 Arizona Inter Tribal Trust Fund Budget)**

**RESOLUTION NO. 13-467**

1 **WHEREAS, P.L. 100-969 Title IV - Arizona-Florida Land Exchange, "Arizona Inter Tribal**  
2 **Trust Fund" was created in response to a land exchange between land in Florida**  
3 **and the property of the Phoenix Indian High School; and**

4 **WHEREAS, income may be used to supplement educational and child-welfare programs,**  
5 **activities and services for the benefit of those Arizona Tribes that were members**  
6 **of the Inter-Tribal Council of Arizona on January 1, 1988 and the Navajo Tribe;**  
7 **and**

8 **WHEREAS, the Tohono O'odham Nation was notified in November 1999 by the Inter-Tribal**  
9 **Council of Arizona that the Nation is scheduled to receive its first allocation of**  
10 **\$400,000.00 in December 1999 under Public Law 100-969, Arizona Inter Tribal**  
11 **Trust Fund; and**

12 **WHEREAS, by Resolution Nos. 2000-253, 03-221, 04-642, 05-577 and 06-202, the Tohono**  
13 **O'odham Legislative Council approved allocations for all of the first and second**  
14 **distributions of \$400,000.00 each of the Arizona Inter Tribal Fund to fund the**  
15 **budgets of the Department of Health and Human Services, Division of Child**  
16 **Welfare Services; and**

17 **WHEREAS, Legislative Council Resolution No. 07-605 allocated \$100,000.00 of the third**  
18 **distribution of \$400,000.00 from the Arizona Inter Tribal Fund to the fund the**  
19 **Department of Health and Human Service, Division of Child Welfare Services;**  
20 **and**

21 **WHEREAS, the Tohono O'odham Nation has submitted an application for the fourth**  
22 **distribution and is approved in amount of \$400,000.00; and**

23 **WHEREAS, the Tohono O'odham Nation has left over funds from previous distributions in**  
24 **the amount of \$414,165.26 from the Arizona Inter Tribal Trust Fund; and**

25 **WHEREAS, the Tohono O'odham Nation Education Department submitted a one-time FY**  
26 **2014 Budget to purchase and replace vehicles under the department for the**  
27 **Head Start Program, the Recreation Division, the Tohono O'odham Nation Youth**  
28 **Council and the Education Administration in the amount of \$814,165.26 to**  
29 **provide safe transportation; and**


30 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**  
31 **Committee of the Tohono O'odham Legislative Council have reviewed the**  
32 **Arizona Inter Tribal Trust Fund FY 2014 Budget and recommend acceptance and**  
33 **approval of the budget in the amount of \$814,165.26.**

1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
2 approves the FY 2014 Arizona Inter Tribal Trust Budget in the amount of  
3 \$814,165.26 for a budget period of October 1, 2013 to September 30, 2014 and any  
4 funds unexpended will be automatically forwarded to the next budget year.

5 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
6 Chairperson of the Nation and any designated official to expend and administer  
7 the budget as attached, provided that any amendments affecting the funds or  
8 funding level is submitted for further prior approval by the Tohono O'odham  
9 Legislative Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup>  
11 day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,073.8  
12 FOR; ~~0~~ AGAINST; 451.6 [03] NOT VOTING; and 421.1 [11] ABSENT, pursuant to the powers vested  
13 in the Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation,  
14 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
15 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 16 of the Act of June 18, 1934 (48 Stat.984).


