RESOLUTION NO. 13-468

1 **WHEREAS, the Tohono O'odham Department of Health and Human Services (TODHHS)**
2 **received word of emergency projects that might be funded by Indian Health**
3 **Service Emergency Funds; and**

4 **WHEREAS, TODHHS responded with a request for funds needed to replace the roof at the**
5 **MOH office building; and**

6 **WHEREAS, the Tohono O'odham Nation received an award notice in the amount of**
7 **\$115,000.00, dated September 27, 2013 to complete the project; and**

8 **WHEREAS, the Health and Human Services Committee and Budget and Finance Committee**
9 **have reviewed the FY14 New Roof budget recommend its approval and adoption.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **approves the New Roof budget in the amount of \$115,000.00 for the replacement**
12 **of the roof at the MOH office building.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairperson and any designated official to expend and administer the budget as**
15 **attached, provided that any amendments affecting the funds or funding level**
16 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
17 **Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH**
19 **day of NOVEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**
20 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
21 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted**
22 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
23 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
24 **the Act of June 18, 1934 (48 Stat.984).**
