6		Ordinance No. 05-81 as amended the Enrollment Committee have received a
7		written statement from 1 tribal member who has expressed their intent to
8		relinquish their membership with the Tohono O'odham Nation and the member
9		is identified in the December 2013 Relinquishment List, which is incorporated
10		by this reference; and
11	WHEREAS,	pursuant to Article IX Section 1 of the Enrollment Ordinance,
12		<u>A member of the Nation may relinquish his membership in the Nation by</u>
13		submitting a written statement clearly expressing an intent to relinquish his
14		membership to the Council, a copy of which must be served on the committee.
15		The written statement must be signed by the person wishing to relinquish his
16		<u>membership or, if a minor or incompetent, by the parent(s), guardian or other</u>
17		<u>person legally authorized to act on his behalf. Relinquishment does not require</u>
18		<u>the approval of the Council, but is effective upon receipt of the statement by the</u>
19		<u>Council and cannot be subsequently denied. Upon recognition by the Council</u>
20		<u>that the individual has renounced his membership, his name shall be deleted</u>
21		from the membership roll.

23		recognizes the individual identified in the December 2013 Relinquishment List
