

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2014 with the Law Firm of Wilmer Cutler Pickering Hale and Dorr, LLP, as Revised, and Rescinding Resolution No. 13-384)

RESOLUTION NO. 13-479

1 **WHEREAS, by Resolution No. 13-384 the Nation approved an Attorney Contract with the law**
2 **firm of Wilmer Cutler Pickering Hale and Dorr, LLP ("the Attorneys"); and**
3 **WHEREAS, the Attorney Contract has not yet been executed; and**
4 **WHEREAS, the Attorney Contract inadvertently omitted a reference to the Attorneys'**
5 **Engagement Letter, which was intended to supplement the Attorney Contract;**
6 **and**
7 **WHEREAS, it is in the best interests of the Nation to approve the revised Attorney Contract,**
8 **as supplemented by the Engagement Letter, substantially in the form attached**
9 **hereto.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
12 **with the law firm of Wilmer Cutler Pickering Hale and Dorr, LLP, for FY**
13 **2014, as revised, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract shall come from sources approved for**
15 **such purposes by the Legislative Council.**
- 16 **3. The Chairperson of the Nation is authorized to execute the Attorney**
17 **Contract.**
- 18 **4. Resolution No. 13-384 is hereby rescinded.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
20 **day of DECEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**

22 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**
23 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
24 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
25 **the Act of June 18, 1934 (48 Stat.984).**
