

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Recognizing the Sells District Council Appointment of Ophelia Pablo as Alternate**  
**to Legislative Representative Arthur Wilson)**

**LEGISLATIVE ORDER NO. 13-483**

1   **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative**  
2       **Council to "enact laws and ordinances for conducting and regulating elections"**  
3       **and provides that the "decision of the Tohono O'odham Council in all election**  
4       **matters, including the eligibility and qualifications of candidates, shall be final"**  
5       **(Constitution, Article VI, Section 1(g) and Article X, Section 7); and**

6   **WHEREAS, since June 2013, the Legislative Council alternate seat to Sells District**  
7       **Representative Arthur Wilson has remained vacant; and**

8   **WHEREAS, pursuant to 12 T.O.C. Chapter 1, Section 1505 (B)(3), when a Legislative Council**  
9       **alternate's seat is vacant, a district may "adopt a resolution appointing an**  
10       **alternate who shall hold office for the unexpired term of his predecessor;**  
11       **provided that the alternate shall not be seated until the Board certifies in**  
12       **writing that the alternate meets all the qualifications for that office"; and**

13   **WHEREAS, on September 24, 2013, the Sells District Council appointed Ophelia Pablo to**  
14       **serve as alternate to Legislative Representative Arthur Wilson on the Legislative**  
15       **Council (Sells District Council Resolution No. SD-87-13); and**

16   **WHEREAS, by letter dated November 14, 2013, the Election Board has certified in writing**  
17       **that Ophelia Pablo meets all the qualifications for the office of Legislative**  
18       **Council Alternate.**

19   **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**  
20       **recognizes the Sells District Council appointment of Ophelia Pablo to serve as**  
21       **alternate to Legislative Representative Arthur Wilson and seats alternate**  
22       **Ophelia Pablo, who shall serve in accordance with the Constitution and laws of**  
23       **the Tohono O'odham Nation and with the rules and procedures of the Legislative**  
24       **Council when Representative Arthur Wilson is unable to attend a Legislative**  
25       **Council session.**

26   **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> day of**  
27   **DECEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
28   **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29   **Article VI, Section 1 (g) and Article X, Section 7 of the Constitution of the Tohono O'odham**  
30   **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**  
31   **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
32   **Section 16 of the Act of June 18, 1934 (48 Stat.984).**


