

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting December 23, 2013 Special Session for a Financial Quarterly Report by the**  
**Nation's Treasurer)**

**LEGISLATIVE ORDER NO. 13-485**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6 **Council with the authority to "by majority vote, call for a special session"**  
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8 **1.D.1.); and**


9 **WHEREAS, the Budget and Finance Committee has requested a special session on**  
10 **December 23, 2013 for a financial quarterly report by the Nation's Treasurer Mr.**  
11 **Frank Espino; and**

12 **WHEREAS, pursuant to Legislative Order No. 13-127, the Nation's Treasurer shall provide a**  
13 **written account of all the Nation's finances, current and projected revenues,**  
14 **and account balances to the Budget and Finance Committee and Legislative**  
15 **Council on a quarterly basis and upon request from the Budget and Finance**  
16 **Committee.**

17 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
18 **special session on December 23, 2013 for a financial quarterly reports by the**  
19 **Nation's Treasurer.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> day of**  
21 **DECEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
26 **June 18, 1934 (48 Stat.984).**
