

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the McKinley County Adult Detention Center Inmate Housing**  
**Agreement Between the Tohono O'odham Nation and McKinley County)**

**RESOLUTION NO. 13-486**

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) Corrections Program**  
2 **operates a Correctional Facility under the P.L. 93-638 contract with the United**  
3 **States Department of Interior; and**

4 **WHEREAS, the Tohono O'odham Nation entered into an Agreement with the McKinley**  
5 **County Adult Detention Center (MCADC) on behalf of the TONPD Correctional**  
6 **Facility to house TONPD Correctional Facility inmates under Resolution No. 08-**  
7 **046 for a period of four years; and**

8 **WHEREAS, this Agreement allowed for four extensions; and**

9 **WHEREAS, amendments one and two were approved by TOLC Resolution No. 09-451 and**  
10 **amendment three was approved by TOLC Resolution No. 11-025; and**

11 **WHEREAS, the fourth amendment was executed in February 2011 with approval through**  
12 **the Executive Counsel and the Attorney General's Office to extend the term of the**  
13 **Agreement under the authority of Resolution No. 11-025; and**

14 **WHEREAS, the Domestic Affairs Committee and the Budget & Finance Committee has**  
15 **reviewed the Inmate Housing Agreement and recommends approval by the**  
16 **Tohono O'odham Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
18 **approves the Inmate Housing Agreement between the Tohono O'odham Nation**  
19 **and the McKinley County Adult Detention Center, substantially in the form**  
20 **attached hereto, and authorizes the Chairman of the Nation to execute it.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby approves**  
22 **to extend the term of the Contract Agreement, provided that any amendments**  
23 **for any other purpose shall be presented to the Legislative Council for review**  
24 **and approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
26 **day of DECEMBER, 2013 at a meeting at which a quorum was present with a vote of 2,946.50**  
27 **FOR; ~~0~~ AGAINST; ~~0~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**  
28 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**  
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
31 **the Act of June 18, 1934 (48 Stat.984).**


