2		by the Legislative Council of the Professional Services Contract between the
13		Tohono O'odham Nation and Michael Brown.

15		Professional Services Contract between the Tohono O'odham Nation and
16		Michael Brown in substantially the form attached hereto in an amount not to
17		exceed \$13,000.
