7		Program due to conflict of interest; and
8	WHEREAS,	the Tohono O'odham Advocate Program has presented a contract for Lawrence
9		Boswell which details the terms and conditions of his services, a copy of which is
10		attached hereto; and
11	WHEREAS,	the Domestic Affairs and Budget and Finance Committee recommends approval
12		by the Legislative Council of the Professional Services Contract between the
13		Tohono O'odham Nation and Lawrence Boswell.
14	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
15		Professional Services Contract between the Tohono O'odham Nation and
16	•	Lawrence Boswell in substantially the form attached hereto in an amount not to
17		exceed \$30,000.
18	BE IT FURTI	HER RESOLVED that the Contract shall be effective as of October 1, 2013 and shall
19		end on September 30, 2014.
20	BE IT FURTI	HER RESOLVED that the funding source for the Professional Services Contract for
21		Lawrence Boswell shall be provided under the operating budget of the Tohono
22		O'odham Advocate Program for fiscal year 2014.
23	BE IT FINAL	LY RESOLVED that the Tohono O'odham Nation Chairman is authorized to execute
24		the Professional Services Contract and any subsequent amendments to extend
25		the term of the Professional Services contract provided that any amendments
26		affecting the funds or funding level shall be submitted for further approval by
27		the Tohono O'odham Legislative Council.
