9		Payson II which details the terms and conditions of his services, a copy of which
10		is attached hereto; and
11	WHEREAS,	the Domestic Affairs and Budget and Finance Committee recommends approval
12		by the Legislative Council of the Professional Services Contract between the
13		Tohono O'odham Nation and Anthony Payson II.
14	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
15		Professional Services Contract between the Tohono O'odham Nation and
16		Anthony Payson II in substantially the form attached hereto in an amount not to
17		exceed \$13,000.
