RESOLUTION NO. 13-496

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution Nos. 09-524 and 11-486**
2 **approved the Mining Royalty Funds Distribution to the Hikiwan District in the**
3 **amount of \$264,509.55; and**

4 **WHEREAS, the Hikiwan District presented the FY 2014 Budget for the Mining Royalty Funds**
5 **in the amount of \$264,509.55; and**

6 **WHEREAS, the Hikiwan District Council, by Resolution No. HDC-13-089, at a special meeting**
7 **held on the 5th of December 2013 approved the Hikiwan District**
8 **Administration's recommendation for the Mining Royalty Funds in the attached**
9 **budget for the amount of \$264,509.55; and**


10 **WHEREAS, the FY 2014 Budget for the Mining Royalty Funds for Hikiwan District was**
11 **reviewed by the Legislative Oversight Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council now**
13 **approves the Mining Royalty FY 2014 Budget as attached in the amount of**
14 **\$264,509.55 for the Hikiwan District Administration.**

15 **BE IT FINALLY RESOLVED that Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairperson and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level**
18 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
21 **day of DECEMBER, 2013 at a meeting at which a quorum was present with a vote of 1,890.0**
22 **FOR; 591.3 AGAINST; 224.2[01] NOT VOTING; and 241.0[05] ABSENT, pursuant to the powers**
23 **vested in the Council by Article VI, Section 1(d)(2) and Article IX, Section 7 of the Constitution of**
24 **the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
25 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
26 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
