

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2014 Professional Services Agreement with Tucson Unified  
School District-Soleng Tom Enrichment Program)**

**RESOLUTION NO. 14-011**

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**  
2 **affordability and quality of child care through funding received in the Child**  
3 **Care & Development Fund Grant for Fiscal Year 2014 from the Department of**  
4 **Health and Human Services, Administration for Children and Families; and**

5 **WHEREAS, the Tohono O'odham Nation's Child Care Program wishes to enter into a**  
6 **Professional Services Agreement with Tucson Unified School District-Soleng**  
7 **Tom Enrichment Program to provide child care services for the Nation's**  
8 **children who are eligible to receive child care services; and**

9 **WHEREAS, the Professional Services Agreement will outline child care services for the fiscal**  
10 **year 2014 ending September 30, 2014; and**

11 **WHEREAS, the Professional Services Agreement has been reviewed and approved by the**  
12 **Human Resources Development Committee and the Budget & Finance**  
13 **Committee of the Legislative Council and each recommend its approval and**  
14 **adoption by the Legislative Council.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
16 **approve the Professional Services Agreement with Tucson Unified School**  
17 **District-Soleng Tom Enrichment Program substantially in the form attached**  
18 **hereto, and further authorizes the Chairman to execute it.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the**  
21 **Professional Services Agreement as attached, including any amendments**  
22 **affecting the funds or funding level.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
24 **day of JANUARY, 2014 at a meeting at which a quorum was present with a vote of 2,946.50**  
25 **FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**  
26 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**  
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
29 **the Act of June 18, 1934 (48 Stat.984).**
