1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **counties, through their respective states, to fund equipment purchases and**
3 **training by departments that provide public safety services within their**
4 **respective jurisdictions; and**

5 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the Arizona**
6 **Department of Emergency and Military Affairs, Arizona Division of Emergency**
7 **Management, FFY 2013 Emergency Management Performance Grant (EMPG),**
8 **Grant No. EMW-2013-EP-000024 in the amount of \$10,000 for the Office of**
9 **Emergency Management; and**

10 **WHEREAS, the FFY 2013 Emergency Management Performance Grant (EMPG) grant and new**
11 **budget has been reviewed by the Budget Office, Office Grants & Contracts,**
12 **Executive Office, Domestic Affairs Committee and Budget & Finance Committee**
13 **of the Legislative Council have reviewed this Budget and recommend its**
14 **approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **and accepts the FFY 2013 Emergency Management Performance Grant (EMPG),**
17 **Grant Award No. EMW-2013-EP-000024, to enhance public safety and the FY2014**
18 **budget as attached on a reimbursement basis from the Tohono O'odham Nation**
19 **General Fund in the amount of \$10,000 for the Tohono O'odham Nation, Office of**
20 **Emergency Management.**

21 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **Emergency Management Performance Grant (EMPG) on a reimbursement basis**
23 **from the Tohono O'odham Nation General Fund and the required Fifty Percent**
24 **(50%) Tribal Match from the FY 2014 Budget Account #001-14-5080 and further**
25 **waives any additional indirect costs to administer this grant.**

26 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation, Office of Emergency Management**
27 **is authorized to expend funds from Emergency Management Performance Grant**




1 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**

11 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
12 **the Act of June 18, 1934 (48 Stat.984).**
