## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Representative Diana Manuel as the IHS Tucson Area Tribal Leaders Diabetes Committee Representative and Representative Racheal Vilson-Stoner as Alternate)

**RESOLUTION NO. 14-044** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council
2	1	with the authority "to promote, protect and provide for public health, peace,
3		morals, education and general welfare of the Tohono O'odham Nation and its
4		members" and with the authority to "consult, negotiate and conclude
5		agreements and contracts on behalf of the Tohono O'odham Nation with
6		Federal, State and local governments and other Indian tribeswithin the
7		authority of the Tohono O'odham Council." (Constitution, Article VI, Section
8		1(c)(2) and Section 1(f)); and
9	WHEREAS,	the Special Diabetes Programs for Indians ("SDPI") was created by Congress to
10		address the disproportionate impact of diabetes in American Indian and Alaska
11		Native communities; and
12	WHEREAS,	the Tribal Leaders Diabetes Committee ("TLDC") was created by the Indian
13		Health Services ("IHS") Director as an advisory committee in matters related to
14		the SDPI and to make recommendations for the improvement of diabetes care
15		and prevention among American Indian and Alaska Native people; and
16	WHEREAS,	the TLDC is comprised of one tribal leader and one tribal alternate from each of
17		the 12 IHS Area Office and are generally tribal elected officials selected by their
18		respective tribe to serve on the TLDC; and
19	WHEREAS,	since 1997, representatives of the Tohono O'odham Nation have served on the
20		TLDC from the Tucson Area, including most recently Representative Adam
21		Andrews and Representative Diana Manuel as his alternate; and
22	WHEREAS,	Legislative Council Representative Adam Andrews no longer serves on the
23		Legislative Council; and
24	WHEREAS,	the Health and Human Services Committee recommends Representative Diana
25		Manuel be appointed as the TLDC Tucson Area representative in place of former
26		Representative Adam Andrews and Representative Racheal Vilson-Stoner serve
27		as Representative Diana Manuel's alternate.

5	immediately expire if the appointed representative no longer serves on the						
6	Health and Human Services Committee for any reason.

12	Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to						
13 14	Section 16 of the Act of June 18, 1934 (48 Stat.984).
