1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**  
2 **affordability and quality of child care through funding provided by the Arizona**  
3 **Department of Economic Security's (A.D.E.S.) Planned Social Services Block**  
4 **Grant (S.S.BG.) Title XX Program; and**

5 **WHEREAS, the Tohono O'odham Nation has entered a cost-reimbursement**  
6 **Intergovernmental Agreement with the Arizona Department of Economic**  
7 **Security for Planned Social Services Title XX Block Grant pursuant to Resolution**  
8 **No. 13-236 and Contract No. ADES 14-053077; and**

9 **WHEREAS, the Central Registry Background Check requirements in the Intergovernmental**  
10 **Agreement have been revised as attached in Amendment #1 to the agreement;**  
11 **and**

12 **WHEREAS, the Human Resources Development Committee of the Legislative Council have**  
13 **reviewed this Amendment #1 and recommend its approval.**


14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
15 **approve Amendment #1 to the Arizona Department of Economic Security**  
16 **Planned Social Services Title XX Block Grant, ADES14-053077**  
17 **Intergovernmental Agreement, Contract No. ADES 14-053077.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes and**  
19 **directs the Chairperson of the Nation to execute Amendment No. 1, provided that**  
20 **any Amendments affecting the funds or funding level is submitted for further**  
21 **prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
23 **day of MARCH, 2014 at a meeting at which a quorum was present with a vote of 2,946.50 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
28 **June 18, 1934 (48 Stat.984).**
