

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting "March 2014 Technical Amendments" to 12 Tohono O'odham Code
Chapter 1 - Elections)**

**DEFEATED
RESOLUTION NO. 14-097**

1 **WHEREAS, the Legislative Council is vested with "all of the legislative powers vested in the**
2 **Tohono O'odham" and is expressly vested with the power to "enact laws and**
3 **ordinances for conducting and regulating elections" (Constitution of the**
4 **Tohono O'odham Nation, Article V, Section 1; Article VI, Section 1; and**
5 **subsection 1(g)); and**

6 **WHEREAS, by Resolution No. 13-328 the Council approved comprehensive amendments to**
7 **the Uniform Election Ordinance and codified the Nation's elections law as 12**
8 **Tohono O'odham Code Chapter 1 - Elections based on extensive public**
9 **comments and public hearings conducted across the Nation; and**

10 **WHEREAS, the Rules Committee has drafted the "March 2014 Technical Amendments" to 12**
11 **Tohono O'odham Code Chapter 1 - Elections, which are incorporated by this**
12 **reference and that are designed to reflect current practices and improve the**
13 **administration of elections; and**

14 **WHEREAS, it is in the Nation's best interest to adopt the "March 2014 Technical**
15 **Amendments."**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends 12**
17 **Tohono O'odham Code Chapter 1 - Elections in accordance with the "March 2014**
18 **Technical Amendments."**

19 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 06TH**
20 **day of MARCH, 2014 at a meeting at which a quorum was present with a vote of 1,234.75 FOR;**
21 **1,711.75 AGAINST; [01] NOT VOTING and [02] ABSENT, pursuant to the powers vested in the**
22 **Council by Article V, Section 1; Article VI, Section 1(g); Article XIV and Article XV of the**
23 **Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on**
24 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


