

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Geneva Acosta to the Election Board for a Five-year Term Ending July 31, 2019)**

RESOLUTION NO. 14-216

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers**  
3 **of committees, boards, officers and agents (Article VI, Section 1(b) Constitution**  
4 **of the Tohono O'odham Nation); and**

5 **WHEREAS, the Nation's Elections law, codified at 12 Tohono O'odham Code, Chapter 1,**  
6 **authorizes the Tohono O'odham Legislative Council to appoint members of the**  
7 **Tohono O'odham Election Board (12 T.O.C. Chapter 1, Article III, Section**  
8 **1301(B)); and**

9 **WHEREAS, the Nation's Elections law provides that board members shall be "appointed . . .**  
10 **for a term of five years or until their successors are appointed" and further that**  
11 **"[a]ppointments to the Board shall be staggered so that the term of office of only**  
12 **one member will end in any single year." (12 T.O.C. Chapter 1, Article III, Section**  
13 **1301(B)); and**


14 **WHEREAS, Geneva Acosta was appointed to the Election Board by Resolution No. 13-321 to**  
15 **complete a term ending July 31, 2014 and she continues to serve until her**  
16 **successor is appointed; and**

17 **WHEREAS, the Rules Committee recommends that Geneva Acosta be appointed to the**  
18 **Election Board for a term ending July 31, 2019.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints**  
20 **Geneva Acosta to the Election Board beginning on August 1, 2014 and ending July**  
21 **31, 2019; provided that she shall continue to serve until replaced by a successor**  
22 **who has been appointed and qualified.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>**  
24 **day of JUNE, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Sections 1 (b); Article X, Section 7 of the Constitution of the Tohono O'odham Nation,**  
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
29 **16 of the Act of June 18, 1934 (48 Stat.984).**


