RESOLUTION NO. 14-217

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
11 **approving applicants for membership contain misspellings in the names of**
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 136-82, 83-**
14 **83, 129-83, 67-84, 910-85, 92-302, 94-109, 94-425, 96-383, 96-260, 96-547, 97-144,**
15 **97-256, 97-322, 97-350, 97-460, 98-174, 98-429, 99-004, 99-200, 99-360, 02-129, and**
16 **14-105 be amended to reflect the correct name spelling or roll numbers for the**
17 **individuals identified in the Amending Enrollment Resolution List June 2014,**
18 **which is incorporated by this reference.**

19 **WHEREAS, the Enrollment Program has further determined that four members were**
20 **erroneously approved twice for membership (two members were originally**
21 **approved by Resolution No. 98-034, one member was originally approved by**
22 **Resolution No. 03-003, and another member was originally approved by**
23 **Resolution No. 09-614); and**

24 **WHEREAS, the Enrollment Program discovered that these same four members were**
25 **approved a second time in Resolution Nos. 98-206, 08-330, and 10-070; and**

26 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 98-206, 08-**
27 **330, and 10-070 be amended to delete the members identified in the Amending**
28 **Enrollment Resolution List June 2014; and**

29 **WHEREAS, the members who were approved in Resolution Nos. 98-034, 03-003 and 09-614**
30 **will retain the roll numbers and approval dates identified in those original**
31 **resolutions.**

7 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that Resolution Nos. 98-
8 **206, 08-330, and 10-070 are amended upon effective dates of those resolutions by**
9 **deleting the members and corresponding information identified in the**
10 **Amending Enrollment Resolution List June 2014.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
12 **day of JUNE, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
14 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
15 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
16 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
17 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


