

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2014 with Sonosky, Chambers, Sachse,
Miller and Munson, LLP)**

RESOLUTION NO. 14-227

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**
2 **Sonosky, Chambers, Sachse, Miller & Munson, LLP, to represent the Tohono**
3 **O'odham Nation in legal proceedings arising from the Nation's Public Law 93-**
4 **638 contract with the Indian Health Service; and**

5 **WHEREAS, the Attorney General has proposed an attorney contract with Sonosky,**
6 **Chambers, Sachse, Miller & Munson, LLP, for fiscal year 2014, for the amount of**
7 **\$35,000.00; and**

8 **WHEREAS, the Health and Human Services, Domestic Affairs, and Budget & Finance**
9 **Committees have reviewed the attorney contract and recommend approval by**
10 **the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that:**

- 12 **1. The Tohono O'odham Legislative Council approves an attorney contract with**
13 **Sonosky, Chambers, Sachse, Miller & Munson, LLP in the amount of**
14 **\$35,000.00 for fiscal year 2014, for the period from the effective date of the**
15 **contract to September 30, 2014, substantially in the form attached hereto.**
- 16 **2. Funding for the attorney contract shall be provided from the operating**
17 **budget of the Office of Attorney General.**
- 18 **3. The Chairperson of the Nation is authorized to execute the attorney contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
20 **day of JUNE, 2014 at a meeting at which a quorum was present with a vote of 2,946.50 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**


