

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2014 Budget Amendment #2 for South Komelic Community  
to Utilize FY 2012 Carryovers in the amount of \$20,290.94)**

**RESOLUTION NO. 14-281**

1 **WHEREAS, at a regular session of the Tohono O'odham Legislative Council held on July 9,**  
2 **2014 the Baboquivari District Administration presented the Budget Amendment**  
3 **#2 for South Komelic Community (see attached budget); and**

4 **WHEREAS, South Komelic Community will be utilizing identified FY 2012 carryovers dollars**  
5 **in the amount of \$20,290.94 to incorporate into their FY 2014 budget; and**

6 **WHEREAS, the Budget Amendment #2 will increase South Komelic FY 2014 community's**  
7 **current budget of \$149,394.74 to a revised amount of \$169,685.68 and will also**  
8 **increase the overall district's FY 2014 budget of \$1,656,175.94 to a revised**  
9 **amount of \$1,676,466.88; and**

10 **WHEREAS, the Budget & Finance Committees of the Tohono O'odham Legislative Council**  
11 **has reviewed the attached Budget Amendment #2 for South Komelic Community**  
12 **and recommend its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reviewed,**  
14 **discussed and approved the South Komelic Community FY 2014 Budget**  
15 **Amendment #2 in the amount of \$20,290.94.**

16 **BE IT FURTHER RESOLVED that this Budget Amendment #2 will identify carryovers for FY 2012**  
17 **for South Komelic Community, in the amount of \$20,290.94 and will deplete all**  
18 **carryover dollars for FY 2012. This Budget Amendment #2 will increase South**  
19 **Komelic Community's current FY 2014 budget in the amount of \$149,394.74 to a**  
20 **revised amount of \$169,685.68 and will also increase the Baboquivari District's**  
21 **overall FY 2014 budget of \$1,656,175.94 to a revised amount of \$1,676,466.88.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **District Chairperson and any designated official to expend and administer the**  
24 **budget as attached, provided that any amendments affecting the funds or**  
25 **funding level shall be submitted for further prior approval by the Tohono**  
26 **O'odham Legislative Council.**
