1 **WHEREAS, by Resolution No. 13-493 the Nation approved an Attorney Contract with**
2 **Attorney at Law Anthony Payson II; and**

3 **WHEREAS, the Advocate Program recommends approval of Amendment No. 1 to the**
4 **Attorney Contract; and**

5 **WHEREAS, funding for the amended Attorney Contract will come from the budget of the**
6 **Tohono O'odham Advocate Program; and**

7 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**
8 **Amendment No. 1 to the Attorney Contract and recommend approval by the**
9 **Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**
12 **Attorney Contract with Attorney at Law Anthony Payson II for FY 2014**
13 **substantially in the form attached hereto.**
- 14 **2. The Chairperson of the Nation is authorized to execute Amendment No. 1 to**
15 **the Attorney Contract.**

17 **day of JULY, 2014 at a meeting at which a quorum was present with a vote of 2,331.65 FOR;**

19 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**
20 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
21 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
22 **Act of June 18, 1934 (48 Stat.984).**
