

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 13-388, and Approving San Lucy District -  
Administration FY 2014 Budget Amendment No. 2)**

**RESOLUTION NO. 14-299**

1 **WHEREAS, by Resolution No. 13-388, the Tohono O'odham Legislative Council authorized**  
2 **the San Lucy District to expend funds in accordance with District's spending**  
3 **plan, further requiring that any amendments/modifications affecting the funds**  
4 **or funding level shall be submitted for further prior approval by the legislative**  
5 **council; and**

6 **WHEREAS, the San Lucy District Council passed Resolution No. SL 06-58-14, "Approving San**  
7 **Lucy District Administration FY 2014 Budget Modification #2", that reduces line**  
8 **item 760 - Land Purchase/Property Taxes by \$6,800.00; and**

9 **WHEREAS, the San Lucy District Administration Budget aggregate amount is reduced from**  
10 **\$952,759.03 to \$945,959.03 a difference of \$6,800.00 and the amount is**  
11 **reallocated to the San Lucy District Health Program Budget to pay anticipated**  
12 **expenses to the end of the budget cycle; and**

13 **WHEREAS, the Budget and Finance Committee have reviewed the budget.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
15 **Amends Resolution No. 13-388 and approves San Lucy District - Administration**  
16 **FY 2014 Budget Amendment No. 2 which reduces the Administration Budget line**  
17 **item 760 - Land Purchase/Property Taxes by \$6,800.00 and that amount is**  
18 **reallocated to the San Lucy District Health Program FY 2014 Budget to pay**  
19 **anticipated expenses to the end of the budget cycle, in accordance with the**  
20 **attached budget.**

21 **BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby authorizes the San**  
22 **Lucy District Chairperson and any other designated District official to expend**  
23 **and administer the budget as attached, provided that any**  
24 **amendments/modifications affecting the funds or funding level is submitted for**  
25 **further prior approval by the Tohono O'odham Legislative Council.**
