

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2015 Budget for the Tohono O'odham Nation Justice
Center and Appropriating Funds in the Amount of \$6,412,715.55)**

RESOLUTION NO. 14-347

1 **WHEREAS, the Fiscal Year ("FY") 2014 will end at midnight, September 30, 2014 and all**
2 **spending authority granted under the FY 2014 budgets will terminate at that**
3 **time; and**

4 **WHEREAS, the Judicial Branch of the Tohono O'odham Nation has prepared and presented**
5 **a budget to the Tohono O'odham Legislative Council ("Legislative Council") that**
6 **reflects the needs of the Branch for the 2015 fiscal year, a copy of the proposed**
7 **budget is attached hereto and incorporated herein by reference; and**

8 **WHEREAS, the proposed FY 2015 Judicial Branch budget includes personnel expenses in**
9 **the amount of \$5,899,849.22 operational costs in the amount of \$508,866.33 and**
10 **capital costs in the amount of \$4,000.00, totaling \$6,412,715.55; and**

11 **WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the**
12 **Legislative Council have reviewed this budget and recommend its approval and**
13 **adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council has reviewed and**
15 **approves the Fiscal Year 2015 budget for the Tohono O'odham Judicial Branch**
16 **in the amount of \$6,412,715.55.**

17 **BE IT FURTHER RESOLVED that funds in the amount of \$6,412,715.55 is appropriated from the**
18 **general funds and authorized to be expended for the Fiscal Year 2015 budget of**
19 **the Tohono O'odham Judicial Branch.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chief Judge and any designated official to expend and administer the Budget as**
22 **attached, provided that any Amendments affecting the funds or funding level**
23 **shall be submitted for further prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
26 **day of AUGUST, 2014 at a meeting at which a quorum was present with a vote of 2,749.6 FOR;**
27 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 196.9[05] ABSENT, pursuant to the powers vested in the**
28 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**


