RESOLUTION NO. 14-350

1 **WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual**
2 **administrative cost of implementing the provisions of the Initiative; and**

3 **WHEREAS, the Initiative Administrative Cost Fund was established to fund the necessary**
4 **initiative administrative requirements; and**

5 **WHEREAS, the Executive Branch has prepared an FY 2015 Budget to continue its Initiative**
6 **administration; and**

7 **WHEREAS, the total FY 2015 Initiative Administration Budget in the amount of**
8 **\$1,638,930.86 and projected the FY 2014 unexpended balance are as follows;**

15 **WHEREAS, the FY 2015 Initiative Administrative Budgets have been presented to the**
16 **respective Legislative Oversight Committees and Budget and Finance**
17 **Committee of the Legislative Council for review and recommend their approval**

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves the following:

- 1. The FY 2014 projected unexpended balance of the Initiative Administrative Budget in the amount of \$36,100.00; and**
- 2. A projected amount of \$1,602,830.86 (the total FY 2015 Initiative Administrative Budget amount of \$1,638,930.86 less the Projected Unexpended Balance of the FY 2014 Initiative Administrative Budgets in the amount of \$36,100.00) will need to be appropriated from the Nation's Gaming Revenues held in the Nation's Desert Diamond Savings Account to the Initiative Administrative Cost Fund to fully fund the Executive Branch FY 2015 Initiative Administrative Budgets for the continued administration of the requirements of Initiative IN-08-97; and**
- 3. The Executive Branch FY 2015 Initiative Administrative Budget in the full amount of \$1,638,930.86 is hereby approved and funds are authorized to be expended as follows:**
