

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Bureau of Indian Affairs One Stop Division FY 2015 Master 477 Budget)**

RESOLUTION NO. 14-365

1 **WHEREAS, the Master 477 budget administers all combined federal programs under the**
2 **Education Department - One Stop Division from October 1, 2014 to September**
3 **30, 2015 in the amount of \$1,223,708.72 with projected allocations; and**

4 **WHEREAS, the Master 477 budget had been developed and cost shared with the Arizona**
5 **Department of Economic Security funding to promote smooth transitional**
6 **services for clients with an effective cost share to promote de-centralized**
7 **services; and**

8 **WHEREAS, the Master 477 budget will be modified when federal allocations have been**
9 **received to reflect the actual allocations; and**

10 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
11 **Committee of the Legislative Council have reviewed this Budget and recommend**
12 **its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **approves and authorizes the expenditure of the FY 2015 Master 477 Budget for**
15 **the Education Department - One Stop Division effective October 1, 2014 to**
16 **September 30, 2015 in the projected amount of \$1,223,708.72 and to utilize the**
17 **Nation's resources pending reimbursement from the Grantor for the continued**
18 **funding of the Grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level is**
22 **submitted for further prior approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
25 **day of AUGUST, 2014 at a meeting at which a quorum was present with a vote of 2,505.7 FOR;**
26 **~~0~~ AGAINST; [01] NOT VOTING; and 443.8[09] ABSENT, pursuant to the powers vested in the**
27 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**
