**RESOLUTION NO. 14-435**

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2015 Tribal Law**  
2 **Enforcement budget to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Law Enforcement Fiscal Year 2015 Budget for the period beginning October**  
4 **01, 2014 ending September 30, 2015 has been reviewed by Domestic Affairs**  
5 **Committee and the Budget and Finance Committee and recommends its**  
6 **approval and adoption.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby adopt, approve**  
8 **and appropriates \$8,277,364.76 from General Fund Revenues to fund the Law**  
9 **Enforcement Fiscal Year 2015 Tribal Budget.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
11 **authorizes the expenditure of funds appropriated to and in accordance with the**  
12 **Law Enforcement FY 2015 Tribal Budget for the period beginning October 01,**  
13 **2014 ending September 30, 2015.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Chairperson and any designated official to expend and administer the budget as**  
16 **attached, provided that any amendments affecting the funds or funding level is**  
17 **submitted for further prior approval by the Tohono O'odham Legislative**  
18 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>**  
20 **day of SEPTEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5**  
21 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**  
22 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**  
23 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
25 **16 of the Act of June 18, 1934 (48 Stat.984).**
