

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2015 Tower User Fees Budget in the
amount of \$154,197.32)**

RESOLUTION NO. 14-492

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on November 6, 2014 to**
2 **address issues pertaining to the Nation; and**

3 **WHEREAS, the Tohono O'odham Legislative Council approved a Management Agreement**
4 **between the Tohono O'odham Nation, Gu Achi District and the Tohono O'odham**
5 **Utility Authority (TOUA) for Jewek Mountain (Resolution #08-586) which allowed**
6 **the Nation and Gu Achi District to obtain a stream of revenue from TOUA's leasing**
7 **space on the transmission tower and the associated equipment building; and**

8 **WHEREAS, the Management Agreement was revised and approved by the Legislative Council**
9 **(Resolution #14-412) superseding Resolution #08-586; and**

10 **WHEREAS, on October 25, 2014, the Gu Achi District Council approved Resolution #205-1410**
11 **for a budget in the amount of \$154,197.32 from the revenue of the tower user fees**
12 **for the following budget line items:**

17 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did**
18 **review the Fiscal Year 2015 Tower User Fees budget submitted and recommend**
19 **for approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **approve the Gu Achi District's Fiscal Year 2015 Tower User Fees Budget in the**
22 **amount of \$154,197.32 as attached hereto.**

23 **BE IT FINALLY RESOLVED that the Gu Achi District has the authority to modify its Fiscal Year**
24 **2015 Tower User Fees budget in accordance with protocols set forth by the Tohono**
25 **O'odham Legislative Council and if any amendments affecting the funds or**
26 **funding levels of the Gu Achi District's Fiscal Year 2015 Tower User Fees budget**
27 **shall be approved by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
29 **day of NOVEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(f)(i) and 2(d) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**




