

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract for FY 2015 with the Law Firm of Dentons US LLP)**

**RESOLUTION NO. 14-493**

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**  
2 **Dentons US LLP to represent the Tohono O'odham Nation in matters relating to**  
3 **the West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract with Dentons US LLP**  
5 **for FY 2015 for the period from October 1, 2014 to September 30, 2015; and**

6 **WHEREAS, the funding for this Attorney Contract will come from sources approved for such**  
7 **purposes by the Legislative Council; and**

8 **WHEREAS, the Domestic Affairs Committee has reviewed this attorney contract and**  
9 **recommends approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**  
12 **the law firm of Dentons US LLP for FY 2015, for the period from October 1, 2014 to**  
13 **September 30, 2015, substantially in the form attached hereto.**  
14 **2. Funding for the Attorney Contract will come from sources approved for such**  
15 **purposes by the Legislative Council.**  
16 **3. The Chairperson of the Nation is authorized to execute the Attorney Contract.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
18 **day of NOVEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
19 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
20 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
23 **June 18, 1934 (48 Stat.984).**


