

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting November 21, 2014 Special Session for a Financial Update by the Nation's Treasurer)

LEGISLATIVE ORDER NO. 14-501

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**
6 **Council with the authority to "by majority vote, call for a special session"**
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**
8 **1.D.1.); and**

9 **WHEREAS, the Budget and Finance Committee has requested a special session on**
10 **November 21, 2014 for a financial update by the Nation's treasurer; and**

11 **WHEREAS, pursuant to Legislative Order No. 13-127, the Nation's treasurer shall provide a**
12 **written account of all the Nation's finances, current and projected revenues,**
13 **and account balances to the Budget and Finance Committee and Legislative**
14 **Council on a quarterly basis and upon request from the Budget and Finance**
15 **Committee.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
17 **special session on November 21, 2014 for a financial update by the Nation's**
18 **treasurer.**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH day of**
20 **NOVEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**
