

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 to the FY 2015 Office of the Treasurer Budget
001-15-1050 to \$544,173.50)

RESOLUTION NO. 14-514

1 **WHEREAS, the Tohono O'odham Legislative Council approved FY 2015 Office of the**
2 **Treasurer Budget by Resolution No. 14-353; and**

3 **WHEREAS, the Office of the Chairman and Vice Chairwoman has assessed the need to**
4 **change budget 001-15-1050 by increasing the Budget from \$528,383.67 to**
5 **\$544,173.50 an increase of \$15,789.83 with Amendment #1; and**

6 **WHEREAS, the Office of the Treasurer Budget Amendment #1 is to increase salary and**
7 **benefit line items for the Treasurer position from E82.2 to E82.7; and**

8 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed this**
9 **Budget Amendment and recommend its approval and adoption.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**
11 **hereby appropriates \$15,789.83 from the general surplus fund and approves the**
12 **Budget Amendment #1 to the Office of the Treasurer to increase the salary and**
13 **fringe benefit line items and to increase the budget from \$528,383.67 to**
14 **\$544,173.50.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
16 **the Chairperson and any designated official to expend and administer the**
17 **budget, as attached, provided that any amendments affecting the fund or**
18 **funding levels of the budget shall be submitted for further prior approval by the**
19 **Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
21 **day of NOVEMBER, 2014 at a meeting at which a quorum was present with a vote of 1,477.8 FOR;**
22 **1,468.7 AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
23 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
24 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
25 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
26 **16 of the Act of June 18, 1934 (48 Stat.984).**
