RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving a Landlord Consent Agreement)

1	WHEREAS,	parsuant to Article VI, Section 1(f) of the Constitution of the Tohono O'odham
2		Nation, the Legislative Council is vested with the power to consult, negotiate and
3		conclude agreements and contracts on behalf of the Tohono O'odham Nation
4		("Nation") with private persons or organizations on all matters within the
5		authority of the Tohono O'odham Legislative Council; and
6	WHEREAS,	pursuant to Article VI, Section 2(d) of the Constitution, the Legislative Council is
7		vested with the power to manage and lease or otherwise deal with lands, or
8		interests in land, and resources of the Nation; and
9	WHEREAS,	in accordance with its constitutional power and authority, the Tohono O'odham
10		Nation entered into a Lease, dated October 19, 1989 and effective on February 12,
11		1990 (the "Lease"), between the Nation, as landlord, and the San Xavier
12		Cooperative Association, Inc., as tenant; and
13	WHEREAS,	the Nation and the San Xavier Cooperative Association are in the process of
14		negotiating an extension of the Lease term until 2016; and
15	WHEREAS,	the San Xavier Cooperative Association has requested a loan from the
16		Community Development Financial Institution of the Tohono O'odham Nation
17		(the "CDFI") and will use the proceeds of the loan for the operation of a farm
18		located on the premises subject to the Lease (the "Premises"); and
19	WHEREAS,	the loan will be secured, in part, by the San Xavier Cooperative Association's
20		interest in certain personal property and equipment located on the Premises
21		(collectively, the "Collateral"); and
22	WHEREAS,	in order to allow the CDFI to enter into the Premises to recover the Collateral
23 24		upon an event of default by the San Xavier Cooperative Association, the
24 25		Legislative Council, in accordance with its constitutional power and authority,
25 26		and acting for and on behalf of the Nation in its capacity as landlord under the
20 27		Lease, wishes to have the Nation execute and deliver a Landlord Consent

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council grants a limited waiver of the Nation's sovereign immunity in favor of the Community Development Financial Institution to resolve disputes arising under the Consent in the courts of the Tohono O'odham Nation by granting injunctive or declaratory relief or actual damages, but such waiver does not extend to consequential or punitive damages, attorney fees, court costs, or any other form of remedy.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH day of <u>NOVEMBER</u>, 2014 at a meeting at which a quorum was present with a vote of 2,176.55 FOR; 769.95 AGAINST; [02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) and Section 2(d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
