

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2015 Contract with Portfolio Evaluations, Inc. as an Investment Consultant)**

**RESOLUTION NO. 14-522**

1 **WHEREAS, the Investment Committee of the Tohono O'odham Nation provides oversight**  
2 **over the financial investments of the Nation; and**

3 **WHEREAS, based on the recommendation of the Investment Committee, the Legislative**  
4 **Council has for some years selected the Bank of America as the custodian and**  
5 **manager of the Nation's invested funds; and**

6 **WHEREAS, in FY 2009, the Nation retained Portfolio Evaluations, Inc., as an independent**  
7 **investment consultant to advise the Nation regarding the investment choices**  
8 **made or recommended by the Bank of America and by any subsequent or**  
9 **additional investment advisors that may be retained by the Nation; and**

10 **WHEREAS, the Investment Committee and Budget and Finance Committees, recommend**  
11 **approving Portfolio Evaluation's FY2015 contract; and**

12 **WHEREAS, under the contract, the Investment Consultant will report as reasonably**  
13 **necessary to the Investment Committee and will, at a minimum, provide two**  
14 **presentations to the full Legislative Council per year; and**

15 **WHEREAS, the term of the contract will be from October 1, 2014 through September 30,**  
16 **2015, and the financial arrangement will be a flat retainer fee for services**  
17 **relating to the Nation's investment portfolio and the 401(k) retirement plan; and**

18 **WHEREAS, the source of funds for the consultant fee will be the investment accounts of the**  
19 **Nation.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 21 **1. Approves the Investment Consultant Contract with Portfolio Evaluations,**  
22 **Inc., as the Investment Consultant for the Nation, substantially in the**  
23 **form attached hereto, for the period from October 1, 2014 through**  
24 **September 30, 2015; and**
- 25 **2. Approves the consultant fees to be paid from the investment accounts of**  
26 **the Nation; and**
- 27 **3. Authorizes the Chairman of the Nation to execute the contract, provided**  
28 **that any amendments or extensions to the Investment Consultant**  
29 **Contract shall be presented to the Legislative Council for further**  
30 **approval.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup>**  
32 **day of NOVEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
33 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
34 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
35 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
36 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
37 **June 18, 1934 (48 Stat.984).**
