15		presentations to the full Legislative Council per year; and

17		2015, and the financial arrangement will be a flat retainer fee for services
18		relating to the Nation's Minors' Per Capita Trust in the amount of \$20,000.00;

20	WHEREAS,	the source of funds for the consultant fee will be the Nation's general fund,
21		which will be reimbursed by the Nation's Minors' Per Capita Trust.

24		Inc., as the Investment Consultant for the Nation relating to the Minors'

27		2. Approves the consultant fees to be paid from the Nation's general fund,
28		which will be reimbursed from the Nation's Minors' Per Capita Trust;
