

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting December 16, 2014 Special Session to Address Enrollment Items)

**LEGISLATIVE ORDER NO. 14-526**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures**  
2 **to regulate all meetings of the Tohono O'odham Council, standing committees,**  
3 **boards and special committees." (Constitution of the Tohono O'odham Nation,**  
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6 **Council with the authority to "by majority vote, call for a special session"**  
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8 **1.D.1.); and**

9 **WHEREAS, the Rules Committee has requested a special session on December 16, 2014 to**  
10 **address enrollment items.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
12 **special session on December 16, 2014 to address enrollment items.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> day of**  
14 **DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
16 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
17 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
19 **June 18, 1934 (48 Stat.984).**
