

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Certification of the Tohono O'odham Eligible Adult Members  
Listing for Third Per Capita 85<sup>TH</sup> Approved Listing Payout Distribution)**

**RESOLUTION NO. 14-528**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
2 **"Tohono O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which**  
3 **authorizes per capita payments to the Nation's members provided that**  
4 **sufficient gaming revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono**  
6 **O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize**  
7 **per capita distribution payments in accordance with the Initiative (Legislative**  
8 **Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan**  
10 **per Legislative Council Resolution No. 06-307; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Third Per Capita**  
12 **Revenue Allocation Plan on July 28, 2006; and**

13 **WHEREAS, the Enrollment Program submits to the Tohono O'odham Legislative Council the**  
14 **Certification Listing for eligible adult members for review and approval for the**  
15 **third per capita distribution; and**

16 **WHEREAS, the total verified adult member for the third per capita 85<sup>th</sup> payout distribution**  
17 **is 1; and**

18 **WHEREAS, pursuant to Resolution No. 06-624 the Legislative Council approved the Master**  
19 **Listing for Eligible Adult members; and**

20 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
21 **verification of a member's eligibility and further certification by the Tohono**  
22 **O'odham Legislative Council.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 24 **1. Accepts and approves the Certification Listing for 1 eligible adult**  
25 **members for the Third Per Capita 85<sup>th</sup> approved listing payout**  
26 **distribution;**
- 27 **2. Authorizes (a) the transfer of \$2,000.00 from the Third Per Capita Money**  
28 **Market Account to the Third Per Capita Checking Account established at**  
29 **Bank of America; and (b) upon the authorized signature of the Nation,**

1 issuance of a check on the Third Per Capita Checking Account in the  
2 amount of (i) \$2,000.00 to each Eligible Member residing in the United  
3 States and listed in the Certification Listing of Eligible Members and (ii)  
4 \$1,400.00 to each Eligible Member residing outside the United States and  
5 listed in the Certification Listing of Eligible Members, with the Balance of  
6 \$600.00 withheld and remitted to the Internal Revenue Service pursuant  
7 to the requirements of federal law;

8 3. Designates Sells as the distribution site for the disbursement of the 85<sup>th</sup>  
9 and subsequent payouts of the third per capita check to members of the  
10 Nation; and

11 4. Authorizes the Chairman of the Nation to execute such other documents  
12 as may be necessary to implement this Resolution.

13 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the disbursement of  
14 funds to each additional eligible adult Tohono O'odham members is  
15 contingent upon verification of a member by the Enrollment Program  
16 and further certification of additional eligible member by the Tohono  
17 O'odham Legislative Council.

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
19 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5**  
20 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**  
21 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**  
22 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
23 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
24 **16 of the Act of June 18, 1934 (48 Stat.984).**
