**RESOLUTION NO. 14-530**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program brought forward Resolution No. 14-467 to correct name**  
14 **spelling or roll numbers for the individuals identified in the Amending**  
15 **Enrollment Resolution List November 2014; and**

16 **WHEREAS, the Enrollment Program has discovered that there was 1 error on the Amending**  
17 **Enrollment Resolution List November 2014; and**

18 **WHEREAS. the Enrollment Program therefore recommends that Resolution 14-467 be**  
19 **amended to reflect the correct roll number for the individual identified in the**  
20 **Amending Enrollment Resolution Amended List November 2014, which is**  
21 **incorporated by this reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
23 **Resolution No. 14-467 is amended upon the effective date of that resolution to**  
24 **reflect the correct roll number for the individual identified in the Amending**  
25 **Enrollment Resolution Amended List November 2014.**
