

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2015 Title III C-1 and C-2 Budget Amendment #1 and Non-Federal Match)

RESOLUTION NO. 14-531

1 **WHEREAS, by Tohono O'odham Legislative Council Resolution No. 14-310 approved the FY**
2 **2015 budgets for Title IIIB; Title III C-1, Title III C-2, Title III E and Title VII**
3 **Advocacy based on initial allocation of \$146,060; and**

4 **WHEREAS, the Tohono O'odham Nation has received from ITCA the Notification of Award**
5 **for Fiscal Year 2015 approving the Total Funding of \$146,060 with a Non Federal**
6 **Match of \$8,845, an overall Total of \$154,905; and**

7 **WHEREAS, the Senior Services Tribal budget 001-6201 has been identified as the**
8 **contributing source to meet the match for in-kind services in the categories of**
9 **Congregate Meals - \$2,433, Home Delivered Meals - \$2,341 and Transportation -**
10 **\$4,176, a total of \$8,845; and**

11 **WHEREAS, it is necessary to amend the Title III C-2 approved budget of \$29,966 by**
12 **decreasing \$1,512 from operational and indirect costs for a revised total of**
13 **\$28,454 and increasing the approved Title III C-1 budget of \$44,046 by \$1,512 in**
14 **operational and indirect costs for a revised total of \$45,558; and**

15 **WHEREAS, the overall total of the two budget amendments and three approved budgets**
16 **does not Change the total award at \$146,060; and**

17 **WHEREAS, the Title III B, Title III E and Title VII Advocacy budgets approved by Tohono**
18 **O'odham Council Resolution No. 14-310 will not change; and**

19 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**
20 **Legislative Council have reviewed the budgets and recommends approval.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **approves:**

- 23 **1. The Title III C-2 Budget Amendment No. 1 reflecting the decrease from**
24 **\$29,966 to \$28,454.**
- 25 **2. The Title III C-1 Budget Amendment No. 1 reflecting the increase from**
26 **\$44,046 to \$45,558.**
- 27 **3. The Non-Federal Match of \$8,845 reflected on the Notice of Award to be**
28 **contributed from the Senior Services Tribal budget account 001-6201.**

3 **attached, provided that any amendments affecting the funds or funding level is**
4 **submitted for further prior approval by the Tohono O'odham Legislative**
5 **Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
7 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
8 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
9 **Article VI, Sections 1(d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted**
10 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
11 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
12 **Act of June 18, 1934 (48 Stat.984).**


