

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Patrick Andrews to the Advisory Council on
Indian Health Care)**

RESOLUTION NO. 14-532

1 **WHEREAS, the Tohono O'odham Constitution vests the Legislative Council with the**
2 **authority to "promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members"**
4 **and to "consult, negotiate and conclude agreements and contracts on behalf of**
5 **the Tohono O'odham Nation with Federal, State and local governments..."**
6 **(Constitution, Article VI, Section 1 (c)(2) and Section 1(f); and**

7 **WHEREAS, by statute, Arizona established the Advisory Council on Indian Health Care in**
8 **1990 to facilitate discussions between the state, federal agencies, and tribes to**
9 **recommend, advocate for, and improve policy and legislation relating to Indian**
10 **health care (Arizona Revised Statutes 36-2901.01); and**

11 **WHEREAS, the Advisory Council on Indian Health Care is comprised of 23 members, 20 of**
12 **whom are tribal members representing different health agencies or serving at**
13 **large, appointed by the governor or serve staggered two year terms; and**

14 **WHEREAS, it would be in the Nation's best interest to nominate a tribal member to the**
15 **Advisory Council on Indian Health Care to advocate for Nation's members; and**

16 **WHEREAS, Tohono O'odham Legislative Council Health and Human Services Committee**
17 **recommends nominating committee member Representative Patrick Andrews,**
18 **a Nation's member, to the Advisory Council on Indian Health Care as a member**
19 **at large.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
21 **nominates Representative Patrick Andrews to the Advisory Council on Indian**
22 **Health Care as a member at large.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that if Governor Janice**
24 **Brewer appoints Representative Patrick Andrews to the Advisory Council on**
25 **Indian Health Care, his appointment shall expire immediately if he no longer**
26 **serves on the Health and Human Services Committee for any reason.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
28 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(c)(2) and Section 1(f) of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
33 **16 of the Act of June 18, 1934 (48 Stat.984).**
