

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY-2015 Real Property Management (RPM) Program Revenue Budget)**

RESOLUTION NO. 14-533

1 **WHEREAS, the Real Property Management Program is tasked to manage, operate and**
2 **maintain 27 San Simon Health Center Staff Housing Units; and**

3 **WHEREAS, the Real Property Management Program is also responsible for the repairs,**
4 **maintenance and grounds keeping to the DaVita Dialysis Center; and**

5 **WHEREAS, the Real Property Management Program is requesting the Tohono O'odham**
6 **Legislative Council to approve FY 2015 Real Property Management Program**
7 **Revenue Budget in the amount of \$516,000.00 to complete capital improvements**
8 **to both the San Simon Health Center Staff Housing Units and DaVita Dialysis**
9 **Center facilities locations; and**

10 **WHEREAS, the Lease Revenue account has a sufficient balance to cover the proposed**
11 **\$516,000.00 FY 2015 Real Property Management Program Revenue Budget; and**

12 **WHEREAS, the Commerce and the Budget and Finance Committees of the Tohono O'odham**
13 **Legislative Council have reviewed this revenue budget and recommend its**
14 **approval.**


15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the FY 2015 Real Property Management Program Revenue Budget in**
17 **the amount of \$516,000.00.**

18 **BE FURTHER RESOLVED that the Tohono O'odham Legislative Council approves any**
19 **unexpended funds at fiscal year-end back to Lease Revenue account.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding levels**
23 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
26 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**
