

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving SAWRSA Purchased Equipment Insurance Budget for fiscal year 2015)**

RESOLUTION NO. 14-534

1 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Legislative Council authorized**
2 **San Xavier Cooperative Association to perform maintenance for the completion**
3 **of the bank stabilization of the Santa Cruz River; and**

4 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Nation purchased equipment**
5 **and materials necessary for the project and the Nation assumes financial**
6 **responsibility of the yearly insurance cost on such equipment; and**

7 **WHEREAS, pursuant to Section .309(a) of the Southern Arizona Water Rights Settlement Act**
8 **of 1982 ("SAWRSA") the Tohono O'odham Nation (the "Nation") received**
9 **\$15,000,000.00 to be held in trust by the nation (the "SAWRSA" Trust Fund); and**

10 **WHEREAS, under Section .309(b) of SAWRSA, the Nation may expend accrued interest and**
11 **dividends on the SAWRSA Trust Fund "for the subjugation of land, development**
12 **of water resources, and the construction, operation, maintenance, and the**
13 **replacement of related facilities on the Papago Reservation (now known as the**
14 **Tohono O'odham Reservation) which are not the obligation of the United States**
15 **under this (SAWRSA) or any other "Act of Congress"; and**

16 **WHEREAS, the San Xavier Cooperative Association has agreed to pay for the yearly**
17 **maintenance costs of the equipment and request that the Nation pays for the**
18 **yearly insurance costs per resolution No. 08-96; and**

19 **WHEREAS, the Equipment Insurance Budget qualifies for the funding under the SAWRSA**
20 **Trust Fund; and**

21 **WHEREAS, the San Xavier District has prepared the attached budget for Fiscal Year 2015 in**
22 **the amount of \$4,087.00 and funded from the SAWRSA Trust Fund; and**

23 **WHEREAS, the Budget and Finance and Water Resources Committee have reviewed this**
24 **budget.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
26 **approves the San Xavier Cooperative Association Maintenance and Operational**
27 **Equipment Insurance Budget in the amount of \$4,087.00 for fiscal year 2015, in**
28 **the form attached hereto.**

29 **BE IT FURTHER RESOLVED that the Legislative Council appropriates the sum of \$4,087.00 from**
30 **the SAWRSA Trust Fund to fund the Equipment Insurance Budget for the fiscal**
31 **year 2015.**

32 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes funding**
33 **from the SAWRSA Trust Fund to cover the yearly insurance costs on the**
34 **equipment.**

35 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
36 **Chairperson and any designated official to expend and administer the budget**
37 **attached, provided that any amendments affecting the funds or funding level is**

1 submitted for further prior approval by the Tohono O'odham Legislative
2 Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD
4 day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;
5 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
6 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
7 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
9 June 18, 1934 (48 Stat.984).
