

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2015 Realty Program Tribal Budget Amendment No. 1)**

**RESOLUTION NO. ~~14-535~~**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2015 Planning and**  
2 **Economic Development Department Realty Program budget by Resolution 14-**  
3 **353; and**

4 **WHEREAS, the Realty Program identified a need for additional staff and to meet those**  
5 **needs submits for review and approval FY 2015 Realty Program Tribal Budget**  
6 **Amendment No. 1; and**

7 **WHEREAS, FY 2015 Realty Program Tribal Budget Amendment No. 1 reclassifies the Land**  
8 **Acquisition Specialist position to a Realty Specialist position; and**

9 **WHEREAS, FY 2015 Realty Program Tribal Budget Amendment No. 1 creates an additional**  
10 **Realty Specialist position within the budget which increases the personnel**  
11 **expense line item and decreases the operational expense line item; and**

12 **WHEREAS, the FY 2015 Realty Program Tribal Budget Amendment No. 1 does not change the**  
13 **Program's FY 15 base budget amount; and**

14 **WHEREAS, the Commerce, Agricultural & Natural Resources and the Budget and Finance**  
15 **Committees of the Legislative Council have reviewed the FY 2015 Realty Program**  
16 **Tribal Budget Amendment No. 1 and recommends it's approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **accepts and approves the FY 2015 Realty Program Tribal Budget Amendment No.**  
19 **1 as follows:**

- 20 **1) The Land Acquisition Specialist position is reclassified to a Realty**  
21 **Specialist Position.**
- 22 **2) An additional Realty Specialist position is created within the budget.**
- 23 **3) There is an increase to the personnel expense line item and a decrease in**  
24 **the operational expense line item.**
- 25 **4) There is no change to the approved FY 2015 base budget funding amount**  
26 **of \$334,102.73.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
28 **Chairperson and any designated official to expend and administer the Budget,**  
29 **as attached, provided that any amendments affecting the funds or funding level**  
30 **is submitted for further prior approval by the Tohono O'odham Legislative**  
31 **Council.**

32 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
33 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
34 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
35 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
36 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
37 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
38 **June 18, 1934 (48 Stat.984).**
