

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Cultural Center & Museum – Donations and Contributions FY 2015 Budget)**

**RESOLUTION NO. 14-536**

1 **WHEREAS, the Cultural Center & Museum preserves Tohono O'odham Himdag by working**  
2 **with O'odham communities to promote and maintain respect and**  
3 **understanding of the Tohono O'odham through material culture collections,**  
4 **educational curricula, cultural programs, and public outreach; and**

5 **WHEREAS, the Cultural Center & Museum has operational needs over and above the normal**  
6 **operational budget; and**

7 **WHEREAS, the Cultural Center & Museum has received donations and contributions and**  
8 **currently has a balance of \$245,751.48; and**

9 **WHEREAS, the Treasury Department of the Tohono O'odham Nation has provided verified**  
10 **documentation stating the accuracy and availability of this amount; and**

11 **WHEREAS, the Cultural Center & Museum has prepared a FY 2015 budget in the amount of**  
12 **\$245,751.48; and**

13 **WHEREAS, the Cultural Preservation and Budget and Finance Committees of the Legislative**  
14 **Council have reviewed this budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **approves the Cultural Center & Museum-Donations and Contributions FY 2015**  
17 **Budget in the amount of \$245,751.48 per the Budget attached hereto.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the Budget as**  
20 **attached, provided that any Amendments affecting the funds or funding level is**  
21 **submitted for further prior approval by the Tohono O'odham Legislative**  
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
24 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
25 **-0- AGAINST; [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council**  
26 **by Article VI, Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
