LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Tabling Consideration of Supplemental Appropriations and Expenditures of Nation's Funds)

DEFEATED LEGISLATIVE ORDER NO. 14-540

1	WHEREAS,	the Constitution of the Tohono O'odnam Nation vests the Tohono O'odnam
2		Legislative Council with broad legislative and fiscal powers, including the power
3		"to manage any funds within the exclusive control of the Tohono O'odham
4		Nation, including proceeds derived from lands and resources of the Tohono
5		O'odham Nation" (Constitution, Article VI, Section 1(d)(2)); and
6	WHEREAS,	the Legislative Council has amended the Gaming Revenue Distribution Formula
7		and taken other necessary steps to protect the long-term stability of the Nation's
8		finances and thereby support government operations and services to Nation's
9		members; and
10	WHEREAS,	there are numerous, competing requests to appropriate additional Nation's
11		funds for projects both within and outside the Nation's government; and
12	WHEREAS,	the Legislative Council Budget and Finance Committee is vested with general
13		oversight of any "activity of the Nation, its enterprises or entities which relates
14		to financial matters" and the committee is delegated the power to "review and
15		recommend legislative measures or actions to the Legislative Council (i)
16		appropriating, authorizing or approving the expenditure of public funds or
17		fiscal resources of the Tohono O'odham Nation" (Budget and Finance Committee
18		Plan of Operation, Section III.B.10. and Section III.C.2.a.); and
19	WHEREAS,	based upon the treasurer's November 2014 financial update; saving, investment,
20		and general fund balances and projections; and anticipated obligations, the
21		Budget and Finance Committee believes it is in the Nation's best interest to
22		preserve existing resources to the maximum extent possible by tabling
23		consideration of supplemental and other funding requests for a six-month
24		period.
25	NOW, THERE	FORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it tables
26		until June 1, 2015 consideration of any agenda item
27		(1) approving or amending the Nation's Executive, Judicial, or Legislative
28		Branch FY 2015 budgets in a manner that requires an additional
29		appropriation of Nation's funds; or
30		(2) appropriating Nation's funds for or authorizing the expenditure of
31		Nation's funds by any entity that is not within the Nation's Executive,
32		Judicial, or Legislative Branch.

BE IT FINALLY ORDERED by the Tohono O'odham Legislative Council that this order does not prevent the Legislative Council from adding to its agenda and considering or approving

- FY 2016 budgets; **(1)**
- contracts, agreements, sovereign immunity waivers, or loan documents (2) that do not require an expenditure of Nation's funds except as a result of an arbitration award, court decision, default, breach, or similar contingency that does not require an appropriation of funds at the time the waiver or approval is granted; or
- an FY 2015 district budget or a district budget amendment increasing the (3) aggregate total of the funds budgeted if the budget or amendment is funded with the district's gaming allocation, mining royalties, savings, investments, or other funds that are not Nation's funds.

The foregoing Order was defeated by the Tohono O'odham Legislative Council on the <u>03RD</u>day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 1,141.45 FOR; 1.805.05 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
