

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Amendment #1 for the 638 Corrections Program FY 2015 Budget)**

**RESOLUTION NO. ~~14-543~~**

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**  
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the FY 2015 Corrections Program budget was approved by Legislative Council**  
4 **Resolution No. 14-348; and**

5 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has submitted**  
6 **amendment No. 1 to the FY 2015 638 Corrections Program budget with funds**  
7 **received under Contract Modification #45 for Operations a onetime funding and**  
8 **Contract Modification #46 a onetime funding for Facility Operations and Facility**  
9 **Management; and**

10 **WHEREAS, budget amendment No. 1 will allow the creating of line items increasing**  
11 **Operational Expense line items and increases the Indirect Cost which has**  
12 **changed the budget amount; and**

13 **WHEREAS, Domestic Affairs and the Budget and Finance Committees of the Legislative**  
14 **Council have reviewed this budget and recommends its approval and adoption.**

15 **NOW THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
16 **approves and authorizes Budget Amendment No. 1 for 638 Corrections Program**  
17 **FY 2015 budget as follows:**

18 **1) Increase budget with a onetime funding under Modification #45 in the**  
19 **amount of \$56,202.00 and Modification #46 in the amount of \$65,576.00 for**  
20 **Facility Operations and \$85,742 for Facility Maintenance.**

21 **2) Increase and create Operational Expense line items.**

22 **3) increased Indirect Cost to \$599,337.24 and changed the bottom line to**  
23 **\$3,541,325.41.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
25 **the Chairperson and any designated official to expend and administer the**  
26 **budget as attached, provided that any amendments affecting the funds or**  
27 **funding level shall be submitted for further prior approval by the Tohono**  
28 **O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
30 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,772.3 FOR;**  
31 **-0- AGAINST; -0- NOT VOTING; and 174.2[06] ABSENT, pursuant to the powers vested in the**  
32 **Council by Article VI, Section 1(d)(3) and 1(f) of the Constitution of the Tohono O'odham Nation,**  
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
34 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
35 **16 of the Act of June 18, 1934 (48 Stat.984).**
