**(Approval of the grant extension for the Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, Tohono O'odham Nation Resource Center Grant No. 2011-IP-BX-0001 and approval of the FY 2015 Budget)**

**RESOLUTION NO. 14-544**

1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded the Department of**  
2 **Justice (DOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA),**  
3 **Tohono O'odham Nation Resource Center Grant No. 2011-IP-BX-0001 through**  
4 **Resolution No. 11-542; and**

5 **WHEREAS, the Tohono O'odham Nation Police Department applied for and was awarded a**  
6 **one year grant extension for the period of October 1, 2014 through September**  
7 **30, 2015; and**

8 **WHEREAS, a FY 2015 budget has been submitted in the amount of \$185,252.93; and**

9 **WHEREAS, Domestic Affairs and the Budget and Finance Committees of the Legislative**  
10 **Council have reviewed this budget and recommend its approval and adoption.**

11 **NOW THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **accepts the one year grant extension for the DOJ, OJP, BJA, Tohono O'odham**  
13 **Nation Resource Center, grant no. 2011-IP-BX-0001 and approves the FY 2015**  
14 **budget in the amount of \$185,252.93 with an effective date of October 1, 2014**  
15 **through September 30, 2015.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the budget as**  
18 **attached, provided that any amendments affecting the funds or funding level is**  
19 **submitted for further prior approval by the Tohono O'odham Legislative**  
20 **Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
22 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
23 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
27 **June 18, 1934 (48 Stat.984).**
