(Approving FY 2015 Budget Amendment #1 for Rodeo and Fair)**

RESOLUTION NO. 14-547

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2015 Budget for the**
2 **Rodeo and Fair by Resolution 14-371; and**
3 **WHEREAS, the Rodeo and Fair submits for review and approval FY2015 Budget Amendment**
4 **#1; and**
5 **WHEREAS, Amendment #1 allows the creating of 7430 RM Grounds; and**
6 **WHEREAS, FY 2015 Amendment #1 is adjusting operational line expenses; and**
7 **WHEREAS, no change to the base budget amount; and**
8 **WHEREAS, the FY 2015 Rodeo and Fair Budget Amendment #1 has been reviewed by the**
9 **Agricultural Natural Resources and the Budget and Finance Committees of the**
10 **Legislative Council and recommend its approval and adoption.**


11 **NOW THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **approved Amendment #1.**

- 13 **1. Creating line item 7430 RM Grounds.**
14 **2. By adjusting Operational Expense line items, The FY 2015 Rodeo and Fair**
15 **Budget will remain at current approved budget amount of \$329,591.27.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council that it hereby**
17 **authorizes the Chairperson and any designated official to expend and**
18 **administer the budget as attached, provided that any amendments affecting the**
19 **funds or funding levels of the budget shall be submitted for further prior**
20 **approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
22 **day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**
23 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat.984).**
