

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Christmas Bonus for the full-time Employees and Officials of the
Executive Branch, Judicial Branch and the Legislative Branch)

RESOLUTION NO. 14-548

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage
2 any funds within the exclusive control of the Tohono O'odham Nation"
3 (Constitution of the Tohono O'odham nation, Article VI, Section 1(d) (2); and

4 WHEREAS, The Tohono O'odham Nation (the "Nation") has prepared a proposal for a
5 Christmas Bonus to each employee of the Executive Branch, Judicial Branch and
6 the Legislative Branch including all Appointed and Elected Officials of the three
7 Branches; and

8 WHEREAS, for the purpose of the legislative action, a Christmas Bonus is defined as a sum
9 of money granted to an employee in addition to regular pay; and

10 WHEREAS, it is proposed that, as of December 12, 2014, full-time employees and officials
11 shall receive \$500.00 as Christmas Bonus.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
13 approves the \$500.00 for each full-time employee of the Executive Branch,
14 Judicial Branch and Legislative Branch including all full-time appointed, and
15 elected officials of the three Branches, provided that employees hired on or
16 after December 12, 2014 shall not be eligible to receive a Christmas Bonus.

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that this payment
18 issued on December 12, 2014.

19 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council appropriates from FY
20 2015 General Fund Surplus a total of \$874,000.16 in accordance with the
21 following estimated schedule:

28 day of DECEMBER, 2014 at a meeting at which a quorum was present with a vote of 1,596.05
29 FOR; 1,350.45 AGAINST; [02] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in
30 the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,
31 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
32 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
33 16 of the Act of June 18, 1934 (48 Stat.984).




