

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Moving Location of Special Session Set by Legislative Order No. 14-549 to
Desert Diamond-Tucson)

LEGISLATIVE ORDER NO. 14-557

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the
6 Council with the authority to "by majority vote, call for a special session"
7 (Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section
8 1.D.1.); and

9 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative
10 Council, as amended, provides that "[a]ll Legislative Council sessions shall be
11 held at the Tohono O'odham Legislative Council chambers located in Sells,
12 Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the
13 legislative representatives may vote to hold a session in some location other
14 than the chambers located at Sells."; and

15 **WHEREAS,** by Legislative Order No. 14-549, the Legislative Council set a December 17, 2014
16 special session to address gaming issues, and the Commerce Committee is now
17 recommending that the session be held at Desert Diamond Casino-Tucson.

18 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it moves
19 the location of the Legislative Council's December 17, 2014 special session to
20 Desert Diamond Casino-Tucson.

21 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16TH day of**
22 **DECEMBER, 2014** at a meeting at which a quorum was present with a vote of **2,772.3 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and 174.2[05] ABSENT,** pursuant to the powers vested in the Council
24 by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
25 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
27 June 18, 1934 (48 Stat.984).
